Re: EPA Comments on TAI's April 25, 2025, Revised Draft Final Remedial Investigation Report for OU 3, Upper Columbia River Superfund Site

Dear Mr. Orr:

EPA has completed review of the Revised Draft Final Remedial Investigation Report (RI Report) for Operable Unit (OU) 3 of the Upper Columbia River (UCR) Superfund site prepared by Teck American Incorporated (TAI). This was the third version of the RI Report for the Upland OU. While TAI's third version is an improvement from the second version, EPA's comments on previously submitted versions of the Upland RI¹, were not fully addressed. Given that unacceptable human health risks have been established, EPA will set aside the unaddressed RI Report issues for now so that we can move toward a final Feasibility Study (FS) that will support remedial action in OU 3. Therefore, this letter constitutes conditional approval and direction to TAI to finalize the Upland RI without significant revision to the revised draft final version.

Approval is conditioned on TAI addressing EPA's issues with the Upland RI in the draft and subsequent versions of the Upland FS. The most prominent issues impacting the FS completion are described in Part 1 of Attachment A to this letter. Additionally, the FS and other future UCR RI/FS documents must account for EPA's comments on the presentation and interpretation of RI findings that are listed in Part 2 of Attachment A. EPA's replies to TAI's responses to comments (RTCs) on the draft final version of the Upland RI (Attachment B) should also be considered when presenting Aquatic RI findings.

However, EPA disapproved the draft and draft final versions of the Upland RI so a third version, developed in collaboration with EPA, was permitted to keep the project moving forward.
